

PARENT/GUARDIAN CONSENT, RELEASE, AND WAIVER FORM

WAIVER AND RELEASE OF LIABILITY

1. The student's participation in the field trip or event described is entirely voluntary and is not a mandatory part of the school's curriculum;
2. We **RELEASE FROM LIABILITY AND WAIVE OUR RIGHT TO SUE** the school district that the above-named student belongs to, and its administrators, directors, employees, school board members, teachers, chaperones, supervisors, volunteers and drivers (collectively "the school district"), **FOR ALL CLAIMS OR DAMAGES**, we separately or collectively may have, **FOR PERSONAL INJURY, BODILY HARM, INJURY TO OR LOSS OF PROPERTY, EMOTIONAL INJURY OR LOSS OF CONSORTIUM**, that may occur at or traveling to or from the event due to the negligence of the school district. We understand that we are not releasing the school district from liability for claims or damages arising from any reckless or intentional act of the school district; and
3. We understand that this **WAIVER AND RELEASE** applies to the above-named student, his or her parent(s) or guardian(s), and their agents, representatives, heirs and assigns.
